Exhibitor agrees to rent table(s) from the Valley of the Sun Doll Club in connection with the club's 43rd Annual Show and Sale, October 11, 2025, being held at the Phoenix Shrine Auditorium, 552 N. 40th Street, Phoenix, AZ 85008.

Hours: Exhibitor shall set up and be ready for public sales by 10 a.m., Saturday, October 11, 2025. Set-up shall be between 2 and 5 p.m. Friday, October 10 and 7 to 9:45 a.m. Saturday, October 11. The show shall run from 10 a.m. until 3 p.m. on October 11. Exhibitor or helper agrees to keep an open, working table until 3 p.m. closing time on said day. **THERE SHALL BE NO PACKING UNTIL AFTER THE SHOW HAS CLOSED.** Failure to comply will be reason for forfeiture of future table privilege.

Furnishings: Club shall supply exhibitor with 8' table(s) and two chairs per dealer. Exhibitor agrees to furnish table covering.

Personnel: Exhibitor shall have one helper only who must be over 12 years of age. No other persons allowed behind tables. Exhibitor and helper must wear identification provided by Valley of the Sun Doll Club. You will receive only one dealer badge and one helper badge per contract.

Salesroom Rules: No decorative or other materials shall be attached to any part of the building so as to damage same. No outside food is allowed inside the venue. No smoking is allowed. Aisles and exits must be kept clear and free of obstruction as per Fire Regulations. All items for sale must be clearly marked. All sales items must be enclosed in bags or wrapped with sales slip secured to the outside. No pets allowed inside the hall and No extra tables except in designated booths. All boxes must be stored under your table or removed from show area.

Indemnify and Release: The Exhibitor releases club from any claim for damage to person or property and agrees to indemnify Club from and against any and all claims arising from Exhibitor's participation.

Taxes and Licenses: The Exhibitor is responsible for any licenses, taxes or fees in connection with sales.

Cancellations: Any requests for cancellations and refunds must be in writing and received by the Table Chairman no later than 2 weeks before the date of the show.

Raffles/drawings: There will be no private or individual raffles or drawings.

Table Prices: All tables are \$85. All space requests will be based on availability when payment is received.

Receipt of the bottom portion of this agreement, along with payment described above, shall be deemed an offer of Exhibitor to rent table(s) according to the terms set forth herein. Your cancelled check shall constitute acceptance of this agreement. Verification will be furnished upon receipt of a Self-addressed Stamped Envelope.
